Reason for Revision: Alignment of PDA(Product Discontinuance Announcement) Milestones to the dates reflected in PCN 119547-01. This revision clarifies the conflict in the Milestones dates for the affected products, by matching the dates stated in PCN 119547-01.

In January 2023, more strict regulations will be applied in the European Union (EU) that specify that all power supplies must meet Titanium efficiency. Therefore, due to these restrictions, Intel will shorten the discontinuance dates.
