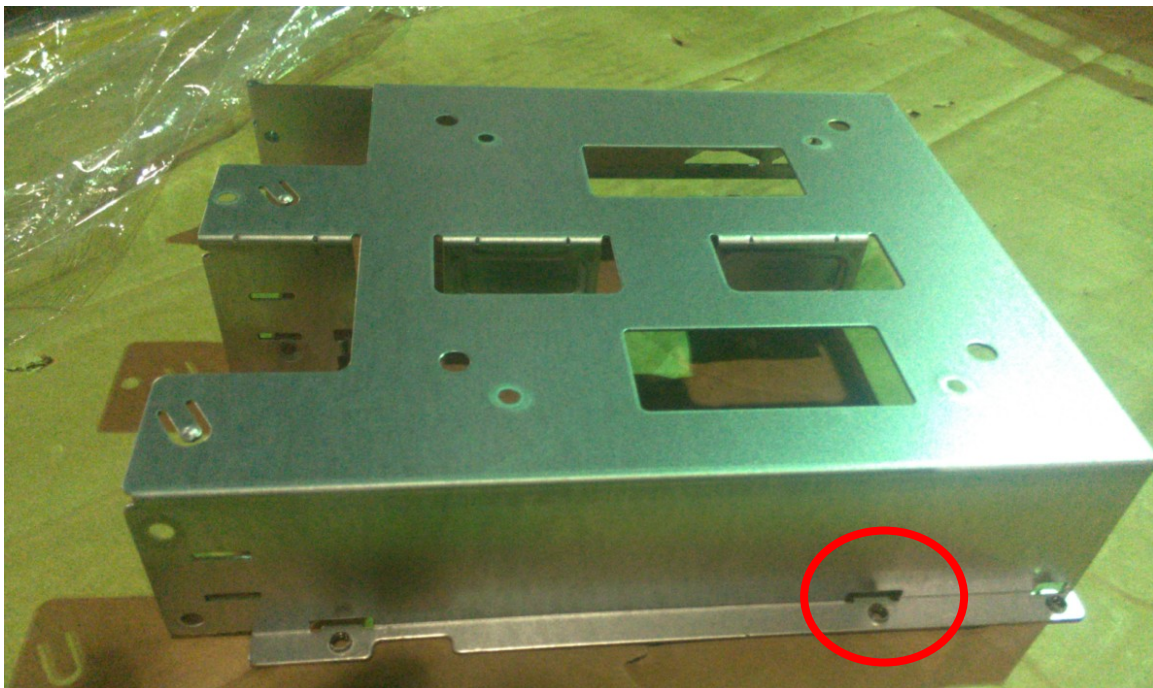

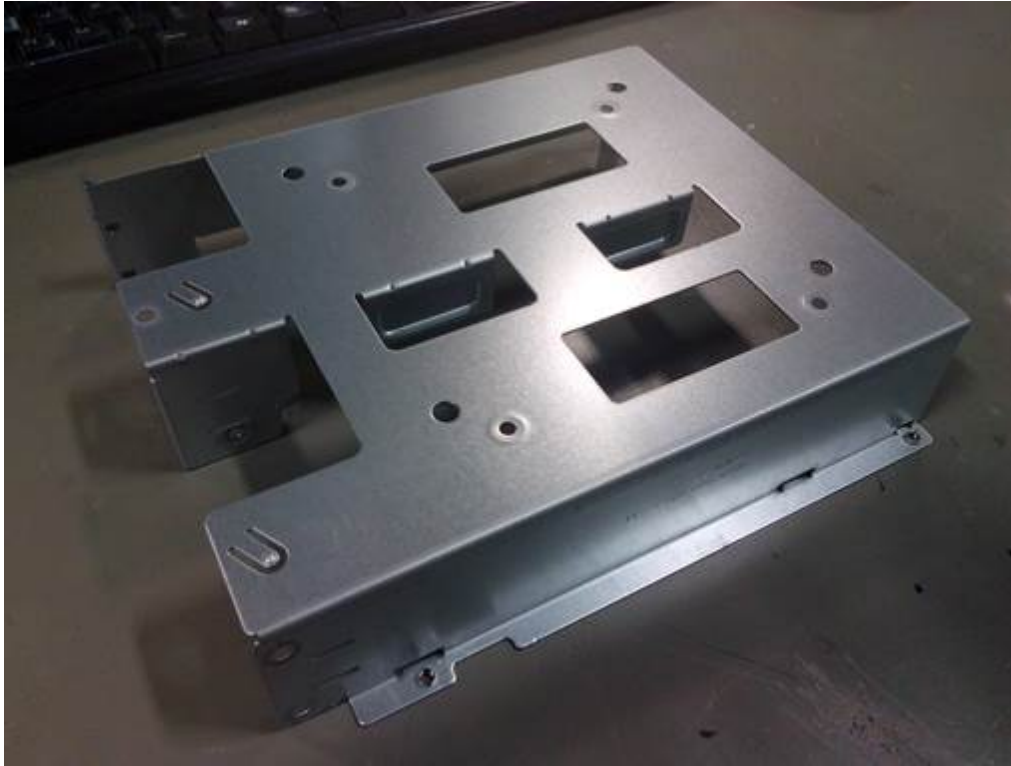
Intel will implement the following change on Intel® Server System R2208BB4GC and R2224BB4GCSAS:
