Description of Change to the Customer:

Intel is implementing the following change on the Intel® Server Chassis P4216XXMHGC and P4208XXMHGC:

Update the 750W Common Redundant Power Supply FXX750PCRPS firmware revision to v100 to prevent a power race condition from occurring during an AC power loss event when the power supply is in cold redundancy mode. The part number of the power supply has been updated from E98791-009 to E98791-010.
