Intel is implementing the following firmware changes on the Intel® Server Board S2600JF in order to support the latest E5-2600 v2 processor boot:

1. Update the BIOS from revision 01.06.0001 to 01.08.0003
2. Update ME from revision 2.01.05.107 to 2.10.07.112
3. Update the Integrated Baseboard Management Controller (BMC) firmware from revision 0116R4010 to 0117R4836
4. Update the FRUSDR from revision 1.08 to 1.10
