Description of Change to the Customer:

Intel is implementing the following changes on the Intel® Server kit A2U44X25NVMEDK2:

1. Replacement of components containing substances listed under EU RoHS exemption 6(c), 7(c) and 15 with exemption free versions. All new components are identical in form factor and function to the replaced ones.

Components containing substances listed under EU RoHS exemption 7(a) are not affected with the exception of one IC.

- 2. Update of the System Firmware installed on the systems that support the kit A2U44X25NVMEDK2:
 - a. Update the BIOS from revision R01.01.0014 to revision R01.01.0016.
 - b. Update the Manageability Engine (ME) firmware from revision 03.01.03.005 to revision 03.01.03.021.
 - c. Update the Integrated Baseboard Management Controller (BMC) firmware from revision 1.13.8932 to revision 01.43.9685.
 - d. Update the FRUSDR from revision 1.11 to revision 1.13
 - e. PSOC update from 1.12 to 1.19 on HSBPs
- 3. Remove J26 programming connector from the Hot-Swap Back Plane.
