Intel is implementing the following change on the Intel® Server System R2308BB4GC:

1. Update the 750W Common Redundant Power Supply FXX750PCRPS firmware revision to v100 to prevent a power race condition from occurring during an AC power loss event when the power supply is in cold redundancy mode.

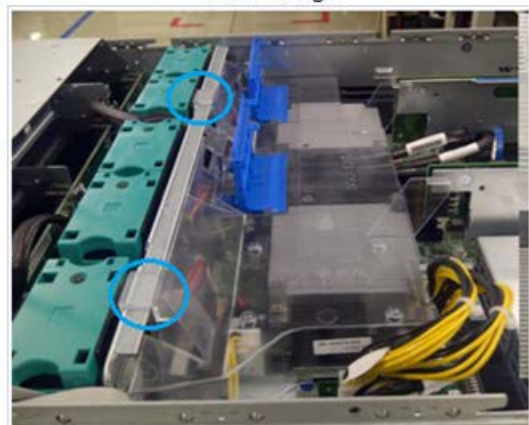
