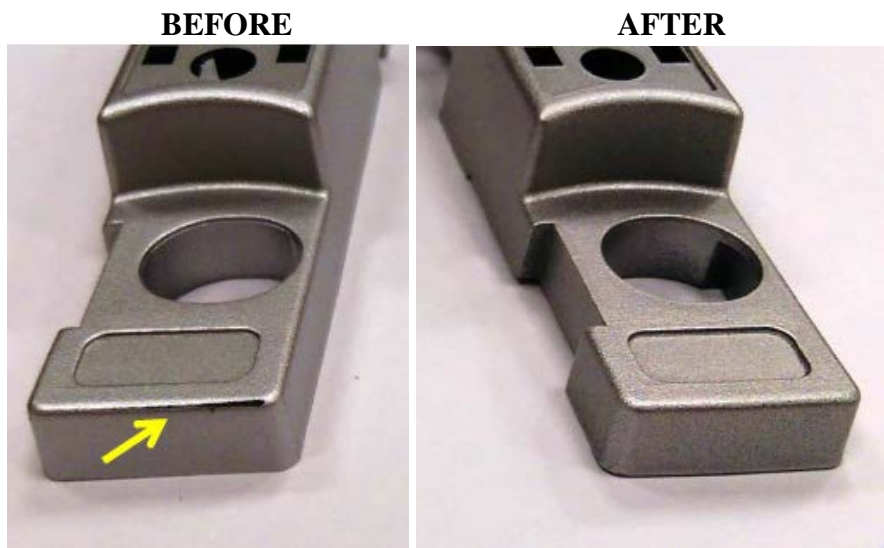

- Improve painting quality on rack ear with UV paint to improve the coating durability.
