Description of Change to the Customer:

Remove 2nd source ATX 2x12 power connector (HAT-012126-V01) part with shorter latch lip. This will ensure the power connector will have full compatibility with older 2x10 power supply units.

Customer Impact of Change and Recommended Action:

This change has been evaluated to ensure there is no quality, reliability, or functional implication to our customers. Intel is not recommending additional qualification of these changes on platforms received from Intel.

Intel will attempt to deplete pre-conversion material before shipping post-conversion material but there is a possibility of Intel shipping mixed inventory. Therefore, customers will need to manage and migrate to the post-conversion material as soon as possible.
