Description of Change to the Customer:

Intel has implemented the following changes on the Intel® Server System P4308CP4MHGC:

1. The Intel® Server Board S2600CP4 Printed Board Assembly (PBA) revision has been updated from E99552-507 to E99552-508 with the following changes:
 - a) Update the BIOS revision from R01.02.0005 to R01.03.0002.
 - b) Update the Manageability Engine (ME) firmware revision from 02.01.05.091 to 02.01.05.107.
 - c) Update the Integrated Baseboard Management Controller (BMC) firmware revision from 1.04.2896 to 1.10.3560.
 - d) Update the FRUSDR revision from 1.03 to 1.07.
2. Change the color of the pull loop from white to blue for the Intel® C600 RAID Upgrade Key RKSATA8 per Intel's specification requirement for system "touch point". See the picture below for reference.

These changes were effective on December 20, 2013 and based on inventory levels customers will start seeing these changes now.
