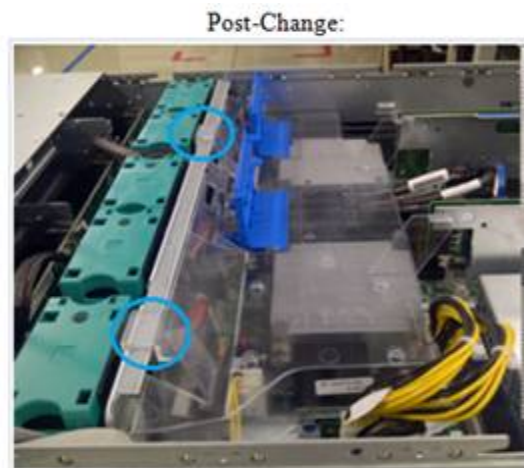

Description of Change to the Customer:

Intel is implementing the following changes on the Intel® Server System R2308BB4GC:

1. Update the 750W Common Redundant Power Supply FXX750PCRPS firmware revision to v100 to prevent a power race condition from occurring during an AC power loss event when the power supply is in cold redundancy mode.
2. Update the air duct to support two internal fixed mount 2.5" Solid State Drives (SSDs).
