Description of Change to the Customer:

Intel is implementing the following changes on the Intel® Server Board S2600KP and S2600TP Product Family accessories:

1. Replacement of components containing substances listed under EU RoHS exemption 7c-I with exemption-free components. All new components are identical in form factor and function to the replaced ones.
