


As a result of changes decreed by the new European Radio Equipment Directive 2014/53/EU, Intel is making the following updates to the Intel® Dual Band Wireless-AC 8260 SKUs listed in the products affected table:

1. The current CE ! Mark on the module label will be modified to remove the Alert Symbol (!) following the CE mark.
2. The “1856” mark is no longer required and will be removed from the label.
3. Addition of the Brazil Regulatory ID to the product label as shown below:
 - a. Anatel ID: 01276-17-02198

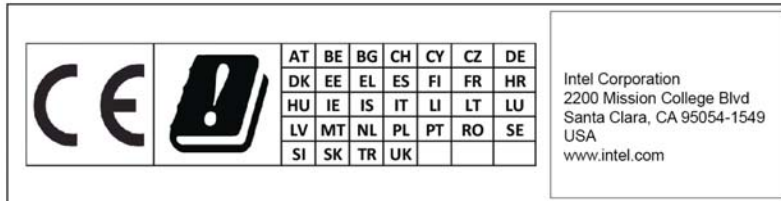

- **Phase 2:** Intel will incorporate into the existing out box labels.
