Description of Change to the Customer:

The product listed on the "Products Affected/Intel Ordering Codes" table below will be discontinued and unavailable for additional orders after the "Last Product Discontinuance Order Date" (see "Key Milestones" above).

Intel estimates there is enough inventory to cover all demand for Intel® Xeon Phi™ Coprocessor (codenamed Knights Corner) 5120D, 3120P and 3120A through the rest of the year. However, there is no viable supply of GDDR5 2Gb memory to build new product, and as a result, we will begin executing the End-of-Life (EOL) process on the these SKUs to the following schedule.

Customer Impact of Change and Recommended Action:

Intel is asking customers interested in these products to have new orders in place no later than May 27, 2016. New orders will be fulfilled with existing inventory while supplies last on a first come, first serve basis.

As you may be aware, Intel intends to implement a CMEP (Code Modernization Enablement Program) on the 7120 products shortly. We will be rolling out the details of the 7120 CMEP in a separate communication.

Please determine your remaining demand for this product and place your "Last Product Discontinuance Orders" in accordance with the "Key Milestones" listed above.
