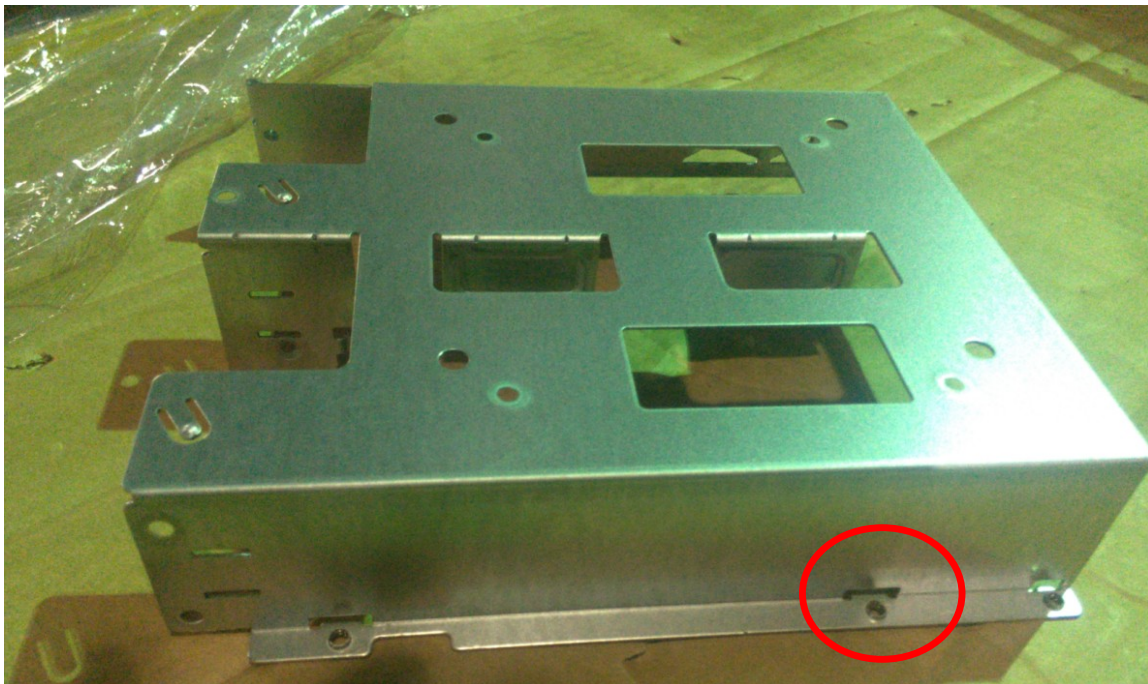

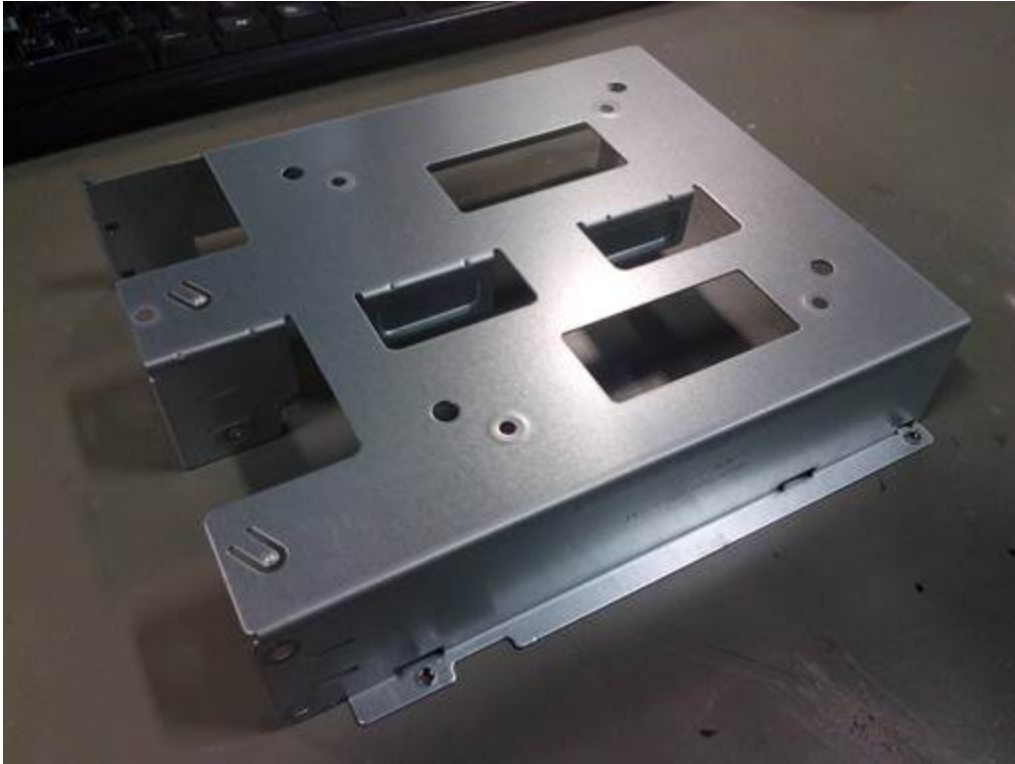
Intel is implementing the following change on Intel® Server System R2308BB4GC:
