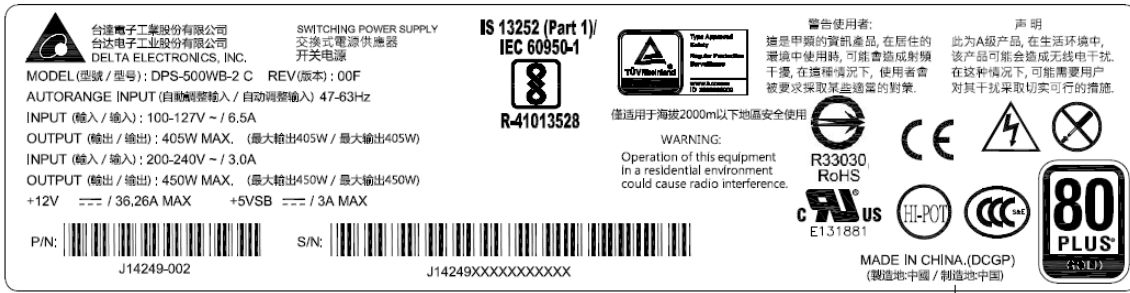


Figure-2 New label
