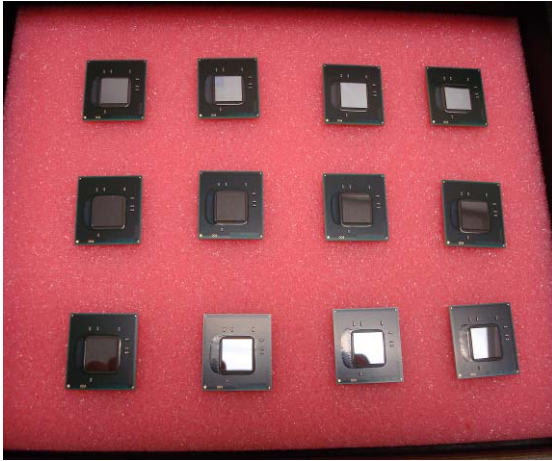
**Reason for Revision:** PCN is for components only. All product categories were inadvertently selected.

**Original PCN:** In order to reduce packaging material that is thrown away and optimize storage space for less than a full tray of samples, Intel® is initiating a Sample Transport Media change in which samples will begin shipping in a small corrugated box (Jewel Box) inside of a padded envelope.

**CURRENT:** Partial I-box in ship box with foam cushions
